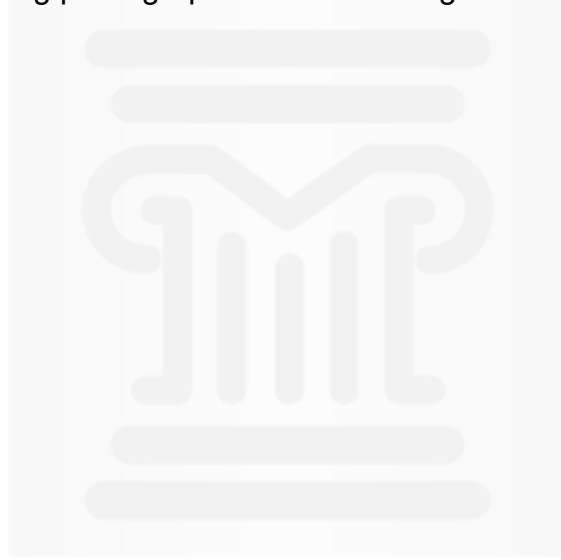

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 14, 2025, Minneapolis Park Police were dispatched to a park located on the 2700 block of 39th Ave S in Minneapolis, Hennepin County, Minnesota on the report that PRESTON CASEY PALMER, DEFENDANT herein, was present at the park to disseminate a substantial quantity of child sexual abuse materials to another individual. Defendant is a teacher at an elementary school that is located next to the park.

When officers arrived, they spoke with several individuals who work for an online group aimed at uncovering online activity involving solicitation of minors for sexual acts and dissemination of child sexual abuse material. These individuals told officers that Defendant had been communicating online with a 17-year-old individual who represented that they were a 13-year-old boy in conversations with Defendant. These conversations began in March of 2025. The conversations were overtly sexual in nature and involved the dissemination of sexual images depicting adults and children. Some of the conversation includes:

- Defendant told the child that he found "cp" (referring to child pornography or child sexual abuse images) at the age of 12 or 13. The child responded that he likes older men even though he's a boy. Defendant responded, "Well you're a boy but you're also becoming a man."
- Defendant referred to the child as "Naughty 13yo" and asked if he was in the USA.
- Defendant asked the child "How often do you jerk off?" Defendant then sent a screenshot of himself with his face visible as well as a screenshot of his clothed crotch area.
- Defendant stated, "My dream is to marry a younger pedo" and stated that he is active online with two other teenaged boys bragging that he had a voice call with one recently during which, "we jerked off."
- Defendant sent the child a photo of a fully nude adult male with an erect penis.
- Defendant stated, "Then I'll want you to glaze me. Cuz cum is kind of like icing. Glaze." "I want your boy frosting."
- Defendant told the child, "Next time you get hard I hope you will try jerking off again."
- Defendant told the child that he is banned from a particular messaging app for "cp."
- Defendant told the child that he is in several trading groups for child sexual abuse material and asked the child, "Do you miss me sending you horny vids?"
- Defendant bragged that he has 87 gigabytes of child sexual abuse materials with more than 1,000 videos and says he keeps them on his "pedophone."
- Defendant told the child that he is a teacher and wished the children he teaches were in the videos. Defendant told the child that he likes skinny boys who are teens and younger. He went on to tell the child that there are several cute boys in school including, "like 3-4 really cute boys in 3rd grade" and that, "there's are some that I pictured naked when I was teaching."
- When the child told Defendant that he finished his homework, he told him, "Good boy," and then said, "Imagine it being said by a man after you finished sucking his c-ck and swallowing his cum" and told the child to call him "Naughty uncle."
- Defendant told the child that he gives away "child porn."
- Defendant sent the child additional images and videos to include an erect adult penis in a hand and sexual acts.

Members of the group also told officers that another member of the group engaged a conversation with Defendant online posing as the child's father. This conversation included the following statements by Defendant:

- Defendant contacted the purported father through an app and stated, "I just found you through the ---- link. I think, are you into boys? Gay perv here into boys and men. If that's not your deal I understand, and I'll move



on." "I've been at this for 20 years I've met hundreds of guys."

- Defendant described how he became sexually attracted to minors.
- Defendant stated that his "age of attraction" is around 8 and up. He went on to describe that, "The younger they are the gentler I'd wanna be." "5-8 is when I'd do more gentle training, touching, fondling, nuzzling, then 8-13 would be more sex focused and 13+ I want to corrupt them and groom them."
- Defendant acknowledges that he is a teacher at an elementary school and offers to share child sexual abuse material with the purported father.
- Defendant asked the purported father what sexual experiences he had with his 13-year-old son.
- Defendant asked the purported father if the 13-year-old has seen child sexual abuse materials previously. The purported father responded, "a bit, but it's not something I force down his throat." Defendant responded, "Hopefully you take occasion to force things down his throat once in a while."
- Defendant then sent the purported father an image of a father and son who he alleged create child sexual abuse materials together.

During this conversation, Defendant agreed to meet up with the purported father and the 13-year-old child at the park in Minneapolis. In a recorded phone call before the meeting, Defendant offered to share child sexual abuse materials with the purported father at the meeting. When Defendant arrived, members of the online group called law enforcement to intervene.

In the presence of law enforcement, a member of the online group said to Defendant, there is child porn on that phone and flash drive that you have to delete. Defendant reached for a black phone and agreed. Upon arrest, Defendant made several spontaneous statements that he was sorry, he was an addict, and he will have a felony and be on the registry. While being arrested, a young child in the park exclaimed, "That's my teacher," near where law enforcement was conducting their work.

In Defendant's possession at the time of arrest were a flash drive and a cell phone. The full contents of these devices are in the process of being forensically reviewed. The cell phone seized contained 18,466 files organized into over 1,000 files. A preliminary review of 40 random files were found to contain images of juveniles performing sexual acts to include:

Preston's iPhone > Photos > 2024-02-09: IMG\_002669.MP4: Video depicting one juvenile male (age 16-18) performing oral sex on another (age 8-10.)

Preston's iPhone > Photos > 2024-06-05: IMG\_010064.MP4: Video depicting a juvenile male (age 6-8), laying on a bed with a grown man fondling him. The room is decorated with children's décor.

Preston's iPhone > Photos > 2024-12-08: IMG\_004970.MOV: Depicts an older female performing oral sex on presumably an older male. A juvenile female (age 5-7) is sitting next to the older female. Older female then has the juvenile female begin oral sex.

Preston's iPhone > Photos > 1989-12-31: IMG\_002526.MP4: Video starts with text saying "Welcome to the Definitive Collection of Boys with a Mouthfull." This video is a compilation of over 40 different videos. Each video containing a different juvenile male between the age of 5-17 years old. All videos involved oral sex, involving one juvenile performing oral sex to several juveniles performing oral sex.

Preston's iPhone > Photos > 2016-12-29: IMG\_002343.MP4: Video shows a juvenile male (age 10-12) dancing in his underwear with an erect penis in front of the camera that he has set to record himself. During the video, the juvenile male then removes his underwear exposing his fully naked body and erect penis.

Preston's iPhone > Photos > 2019-01-17: IMG\_008666.MP4: Video shows a juvenile male (age 7-8) pulling his shorts down and grabbing his buttocks with both hands as he bounces up and down. The

juvenile male then spreads open his buttocks with both hands before inserting his left index finger into his anus. The juvenile male rapidly sticks his finger in and out of his anus before pulling it out. Juvenile male then faces to the side, pulls down the front of his shorts, and pulls out his semi erect penis. Juvenile male then masturbates with gyrations similar to "thrusting."

Preston's iPhone > Photos > 2018-04-14: IMG\_011303.MP4: Video shows a prepubescent juvenile male who appears to be changing in a bathroom or locker room. A camera is held over the top of the stall in a voyeuristic fashion to capture the naked juvenile changing. The juvenile's genitals are clearly seen in the video.

Preston's iPhone > Photos > 2017-10-27: IMG\_011803\_original.MOV: This video shows an older teenage male (age 15-20) having anal sex with a juvenile prepubescent male (age 6-9).

Preston's iPhone > Photos > 2019-01-17: IMG\_007046.MP4: Video depicts a juvenile male (age 10-13) masturbating.

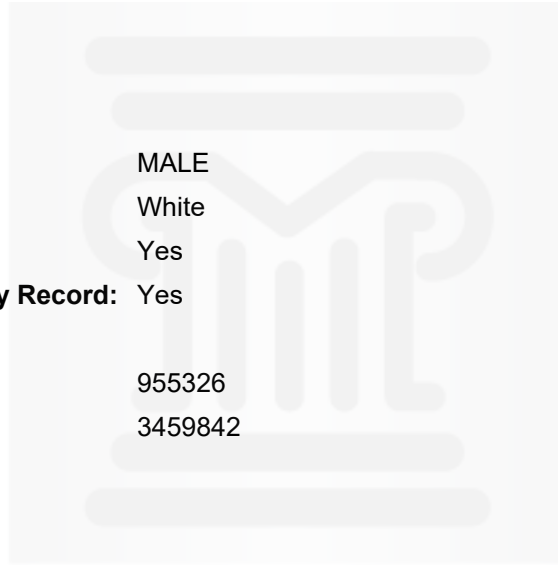
